The attention of the all the RJDSEs and the DEOs in the State are invited to reference 1st read above, wherein Government have issued norms for Rationalization of Schools, Posts and Staff under various managements Government, ZP and Mandal Parishad Schools in the State. Accordingly instructions / guidelines issued in the reference 2nd read above.

In the references 3rd to 9th read above certain DEOs have requested for issue of clarifications for the issues raised therein. The following clarifications are issued and the RJDSEs and DEOs are requested to take necessary immediate action in the matter promptly.

Exemptions is mentioned only in case of Primary Schools consolidation but Not mentioned in case of Consolidation of UP Schools / High Schools in GO Ms No.29, dated: 22-05-2017

A clarification is requested whether exemption is considered for UPS / HS having SC/ST Areas, Hillocks, Streams, National High Ways, Railway Tracks, etc.

Exemption is only for primary schools for SC / ST areas and natural barriers keeping in view of the distance factor of 1 Km. In exceptional cases only, exemption may be considered for Upper Primary and High Schools with major natural barriers not deviating from the distance norm after approval of District Collectors
