ORDER:

In the G.O. 1st read above, Government have issued orders declaring 05.10.2014 (Sunday) as General Holiday on the occasion of Baqar Eid Festival (Eid-ul-Azha) and 13.10.2014 (Monday) as Optional Holiday on the occasion of Eid-e- Ghadeer.

2) In the reference 2nd read above, the Chief Executive Officer, Andhra Pradesh State Wakf Board, Hyderabad, has recommended to declare the General Holiday on the occasion of Baqar Eid Festival (Eid-ul-Azha) on 06.10.2014 (Monday) instead of 05.10.2014 (Sunday) and Optional Holiday on the occasion of Eid-e-Ghadeer on 14.10.2014 (Tuesday) instead of 13.10.2014 (Monday), as per moon sight.

3) The Government, after careful consideration of the matter, have decided to change the **General Holiday** on the occasion of **Baqar Eid Festival (Eid-ul-Azha) to 06.10.2014 (Monday)** instead of 05.10.2014 (Sunday) and **Optional Holiday** on the occasion of **Eid-e-Ghadeer to 14.10.2014 (Tuesday)** instead of 13.10.2014 (Monday).
