The following Notification shall be published in the Andhra Pradesh Gazette.

NOTIFICATION

In exercise of the powers conferred by the section 78 read with section 99 of the Andhra Pradesh Education Act, 1982(Act 1 of 1982) and under the proviso to Article 309 of the Constitution of India and in supersession of the special Rules for the post of Mandal Educational Officer, issued in G.O.Ms.No.505 Education (Services-I) Department Dated 16.11.1998, the Governor of Andhra Pradesh hereby makes the following special Rules for the post of Mandal Educational Officer, Revenue Mandal (Urban).

01. Short Title:-

These Rules may be called as Andhra Pradesh Educational Service [Mandal Educational Officer, Revenue Mandal (Urban)] Rules.

02. Constitution:-

The post of Mandal Educational Officer, Revenu Mandal (Urban) shall constitute a separate category in Andhra Pradesh Educational Service Rules.

03. Method of Appointment and Appointing Authority:

| Mandal Educational Officer, Revenue Mandal (Urban) | Appointment by transfer from the Head Master Grade-II (Gazetted) in Government School. | Regional Joint Director of School Education concerned. |

04. Qualifications:-

No person shall be eligible for appointment by transfer to the post of Mandal Educational Officer, Revenue Mandal (Urban), unless he possess a Bachelor's Degree in Arts/Science/Commerce and B.Ed. Degree from a University of India established or incorporated by or under a Central Act, Provincial Act or a State Act or an Institution recognized by the University Grants Commission or an equivalent qualification.

05.Age:-

No person shall be eligible for appointment by transfer to the post of Mandal Educational Officer, Revenue Mandal (Urban), if he / she completed 55 years of age as on 1st May of the year.

06. Minimum Service:-

No person shall be eligible for appointment by transfer to the post of Mandal Educational Officer, Revenue Mandal (Urban) unless he / she has put in not less than 5 years of Service as Head Master Grade-II (Gazetted) Government School.

07. Reservation of Appointment:-

The Rule of Reservation as prescribed in rule-22 of the Andhra Pradesh State and Subordinate Service Rules 1996 and orders issued thereon from time to time shall apply to the post of Mandal Educational Officer by appointment by transfer from the category of Head Master Grade-II (Gazetted).

08. Postings and Transfers:

The Regional Joint Director of School Education concerned shall be the competent authority for transfer and posting.

09. Unit of Appointment:

The Unit of Appointment for posting and transfer is the Zone concerned.
