In the reference 1st read above, the Director, SCERT, A.P. Hyderabad has informed that as per the instructions of the Govt. Memo.No. 7320/C&TBP/2006-2, dated 8-8-2006, the SCERT, Hyderabad has developed textbooks in State Syllabus in eight languages for classes I, III & V and have been introduced in the schools in entire state from the Academic Year 2009-2010 onwards and also as per the orders issued in Govt. Memo.No.8127/PE-Prog.II/A2/2009, dated 4-11-2009, the SCERT has initiated the task of development of text books material in respect of classes II, IV & VI in eight languages such as Telugu, English, Hindi, Urdu, Tamil, Kannada, Marathi and Oriya which are to be introduced from the academic year 2010-11 onwards.

The Director, SCERT, A.P.Hyderabad has stated that for revision of syllabus for classes VII to X which is a $1^{\rm st}$ level task before initiating task of development of text books for classes VII to X as per the norms and guidelines issued by the Government of India through NCF 2005 document and requested the Government to accord permission in the matter.
- 3. In the reference 3rd read above, the Commissioner & Director of School Education, A.P.Hyderabad has furnished financial requirements for revision of syllabus for classes VII to X classes and also preparation of New Text books for the classes VII and IX during the year 2010-2011 to be introduced from 2011-2012 academic year and also requested to introduce "Life and Teachings of Swami Vivekananda" as a Non detailed Text at High School level. The same is considered to introduce under Moral Education texts and requested the Government to accord permission on the following:-
 - (i) to review syllabus from class VII to X during 2010-11 as per NCF-2005 guidelines.
 - (ii) to develop textbooks for class VII and IX during the year 2010-11 to be introduced from 2011-12 academic year

- (iii) to develop syllabus and textbooks for Moral Education for class I to X including "Life and Teaching of Swami Vivekananda".
- (iv) To provide additional budget of Rs.1,94,51,595/- for the purpose mentioned at (i), (ii) and (iii) above.
