In this connection, the following clarifications are issued and they are requested to take further necessary action in the matter promptly.

At present model schools which are having LFL HM post are decreased in strength and become less than 80 strength. Hence, it is requested to clarify to re allot the LFL HM pot in the model school with less than 80 strength to other schools or not. 8.	(Rule 8 of G.O.29) Total 551 SGT Telugu vacant posts are made surplus in Prakasam district during previous rationalization of primary schools. Appointment orders are issued to DSC-2014 newly recruited candidates in Prakasam district as per notification already issued as per the options in recruitment counselling 271 newly recruited candidates who are in DEO Pool without posts in schools for sake of the salaries as per instructions of the CSE. The surplus posts were allotted to mandals to draw the salaries to the DEO Pool candidates by the MEOs and they are being paid salaries from school points. They were allotted temporarily to school point as per need after rationalization. They are at mandal point only.
